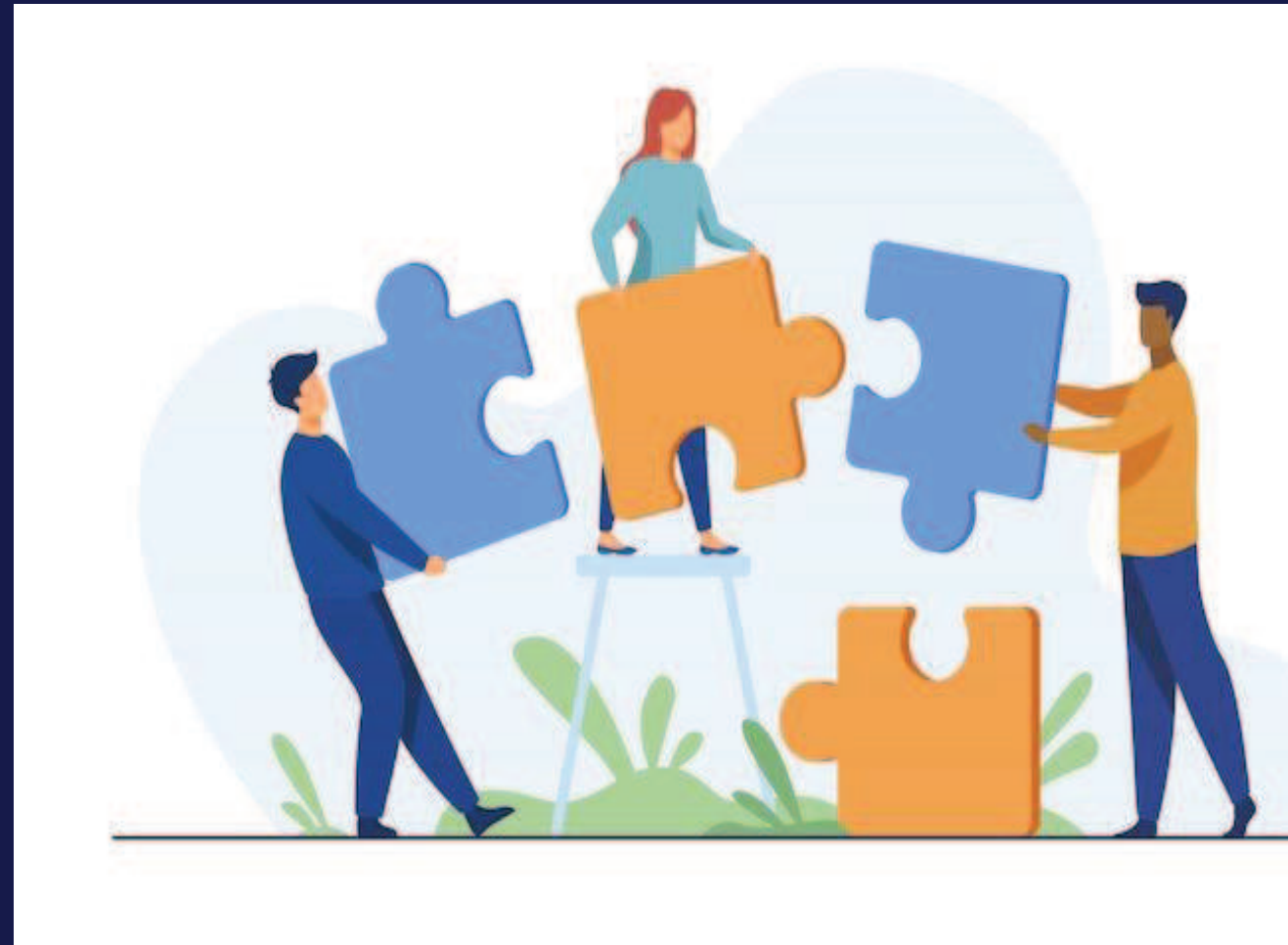

- We have introduced MCRF (member customer relationship form) a document that gives BCEAK power to demand unsettled payments from member's clients.



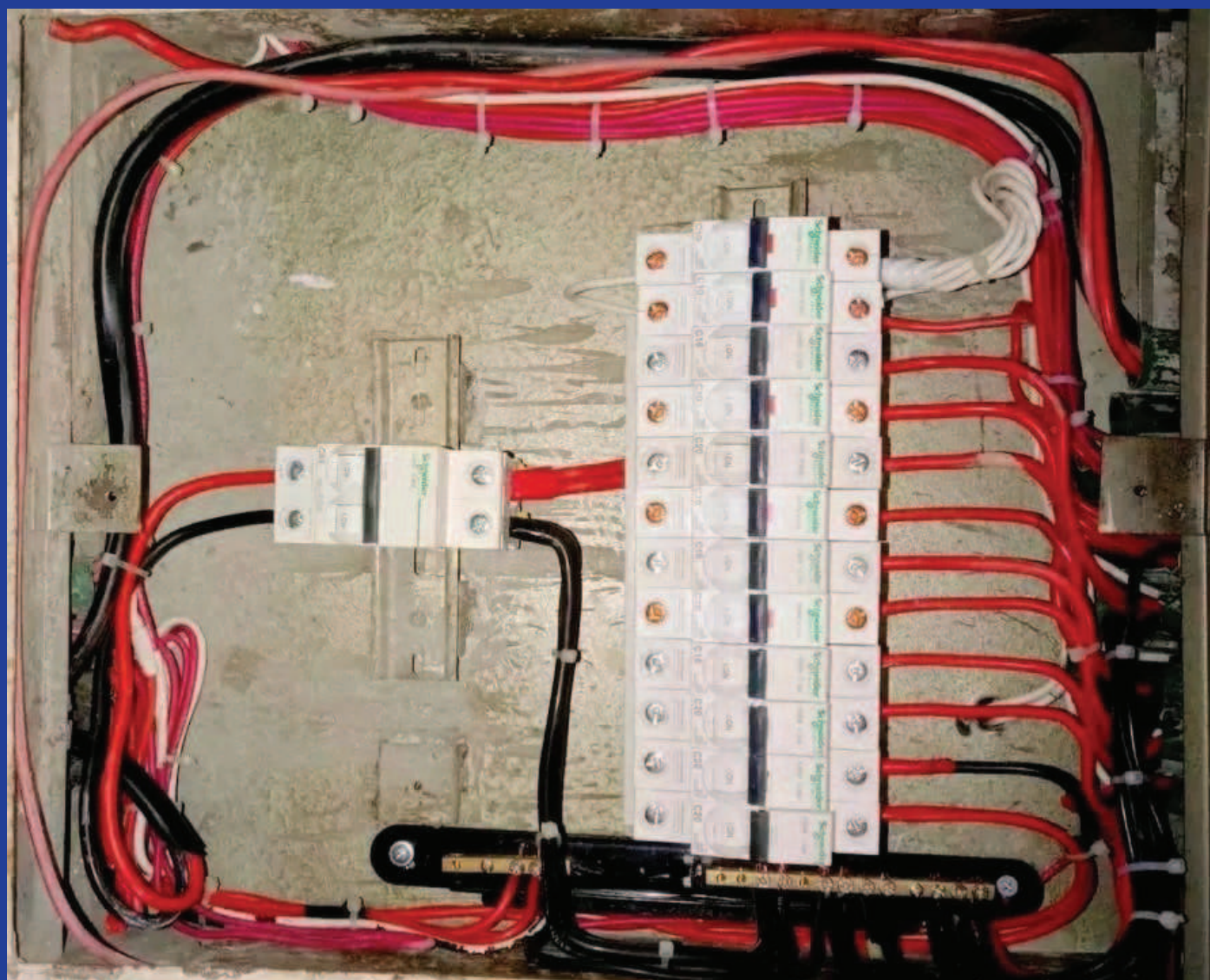
- We have diligently selected a legal team to represent BCEAK members, employees and officials on legal matters including taking up unsettled/delayed payment cases to courts

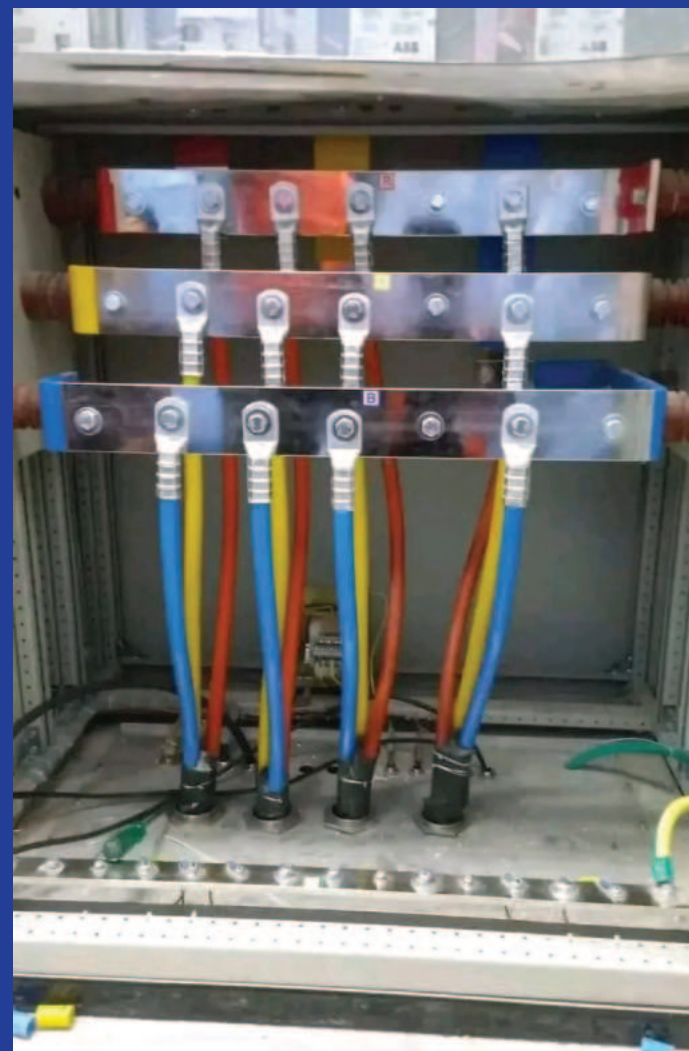
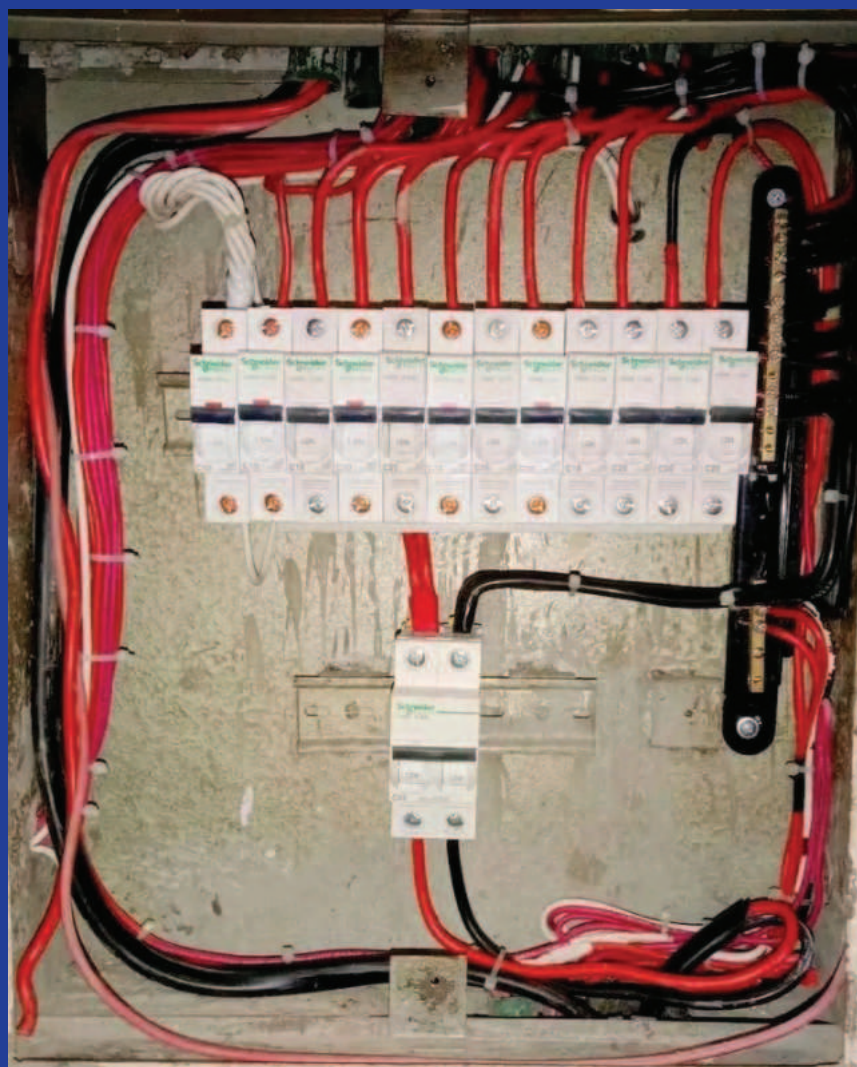
